#### CONTEST RULES

### "Join the REM's Arrival"

**Participant identification.** For the purposes of these Contest Rules, a participant is the person whose name appears on the Entry Form and will be awarded the prize if declared a winner.

**Organizer identification**. The contest is held by CDPQ Infra (the "Contest Organizers") and will run from October 21, 2025, at 08:00:01 (ET) until 11:59:01 (ET) on October 26, 2025 (the "Contest Period").

#### 1. ELIGIBILITY

The contest is open to anyone who:

- Resides in Quebec
- Has reached the age of majority in the Province of Quebec (18+)

However, the following are not eligible: employees, representatives and agents of the Contest Organizers or any company, corporation, trust or other legal entity controlled by or related to them, their advertising and promotional agencies, suppliers of equipment and services related to this contest, and their immediate family members (brothers, sisters, children, father, mother), their legal or commonlaw spouse and all persons living with such employees, representatives and agents.

## 5. DRAW

A maximum of 30 "Local Opening Ceremony" Prize winners will be selected to participate in local opening ceremonies, i.e. five winners per station with participants whose first three characters of their primary residence postal code correspond to an area in proximity to one of the named stations. The Contest Organizers reserve the right to assign winners to any of the six stations based on the contest results.

## 6. CLAIMING PRIZES

To be declared a winner, a participant must:

- **Correctly answer** the mathematical skill-testing question on the entry form;
- **Reply to the Contest Organizers' email** within 48 hours of their making initial contact within one week of closing the contest online;
- **Complete and sign** the Declaration Form which will be emailed to the winner by the Contest Organizers stating that the winner has satisfied all the conditions outlined herein and return it to the Contest Organizers within 48 hours of receipt;
- **Be included on the winners list and receive the reminder email** with full details two weeks after the draw;
- Where applicable, provide, upon request and in a timely manner, one piece of photo ID.

Failure to satisfy any of the above conditions will result in the selected participant being disqualified and deemed to have forfeited his or her prize.

## 7. GENERAL CONDITIONS
